

## Q. How many people can I register in my bubble?

You can register a maximum of six (6) people per bubble.

# Q. If I have a member of my bubble unable to attend at the last moment can I bring another guest?

Yes, you can bring another person to be part of your bubble if someone who registered with you is no longer able to attend. Your bubble cannot exceed six (6) people.

## Q. Do I have to arrive at the same time as the rest of my bubble?

We encourage the six individuals registered for the same bubble to arrive together. However, if it is not possible to arrive together, all guests must have a copy of the registration receipt, either digital or printed copy. The individual who registered the bubble will have a copy of the receipt and must provide it to all guests in the bubble if not arriving together.

## Q. During the event, can I visit another bubble or cohort area?

No. Due to current public health guidelines, all members of a bubble must remain in the bubble area. We also ask that you ensure any children part of your bubble do not leave the bubble or wander in the area. You can leave your bubble to purchase food from the concessions or to visit the washroom areas; when doing so, it is recommended that you follow physical distancing and respect the space of others.

#### Q. Are washroom facilities available on site?

Yes, washrooms facilities are available on site, with each cohort assigned a specific washroom area to support all public health guidelines. The washroom facilities will be cleaned regularly throughout the event.

## Q. Do I have to follow all Covid-19 guidelines as set by provincial public health officials?

Yes, if you or any member of your bubble are experiencing any of the Covid-19 screening symptoms, we ask that you not enter the main event area.

#### Q. Am I required to wear a mask?

Face masks are to be worn when going to the washroom area, food concessions, first aid area or speaking with a staff member or volunteer. When you are within your bubble area, you are not required to wear a face mask.

## Q. Are alcoholic beverages permitted at this event?

No, alcoholic beverages are not permitted on the event site and will not be served during the event.

#### Q: What can guests bring to the event?

As the event is outdoors at Paradise Park, we suggest you bring blankets or chairs to sit on within your bubble area. Food and non-alcoholic beverages are available for purchase, but you can bring food and non-alcoholic beverages with you. Strollers are permitted if required for young children. And of course, you'll need face masks, and hand sanitizer is always recommended!

## Q: What are guests not allowed to bring to the event?

Guests are not permitted to bring any alcohol to the event. We also ask that you do not bring any glass bottles to the site.

## Q: What time do the gates open for the event?

There are two sessions for the Main Event, an afternoon session and an evening session. For the Afternoon Session, the gates will open at 12:00 p.m. and for the Evening Session, the gates will open at 3:30 p.m. Please note, that if you are attending both sessions, you will have to leave the site once the afternoon session has ended so that the area can be cleaned and set-up for the evening session.

## Q. How do I access the event area?

To access the event area, enter using Sarah Davis Way and staff will direct you to the appropriate parking area. Staff will also direct you to the entrance for the site.

## **Q: What time is Entertainment?**

There are two sessions for the Main Event, an afternoon session and an evening session. For the Afternoon Session, the gates will open at 12:00 p.m., with the entertainment scheduled to start at 12:45 p.m. and continue until 3:10 p.m. For the Evening Session, the gates will open at 3:30 p.m., with the entertainment scheduled to start at 4:00 p.m. The fireworks are scheduled for 10:00 p.m. Please note, that if you are attending both sessions, you will have to leave the site once the afternoon session has ended so that the area can be cleaned and set-up for the evening session.

# **Q.** If I registered for both the afternoon and evening sessions, do I have to leave the event site between sessions?

Yes, if you are attending both the afternoon and evening sessions, you will have to leave the site once the afternoon session has ended so that the area can be cleaned and setup for the evening session. Please note you will be required to provide your registration receipt for the evening session to re-enter the event area.

## Q: Can I purchase food?

Yes, food concessions will be on site and food and non-alcoholic beverages will be available for purchase.

#### Q: What happens if it's raining on July 17th?

This event is going ahead rain or shine! We recommended planning ahead and preparing for all possible weather conditions.

## **Q:** Is re-entry into the event allowed?

It is recommended that once you enter the event site for the session that you registered that you not leave. This is to support all public health requirements.

## **Q: Is Accessible Parking available?**

Yes, Accessible Parking areas are available to those who with a valid accessible parking pass. If you need to access this parking area, please advise staff when you arrive on site and you will directed to the appropriate parking area.

## **Q: Will First Aid services on site?**

Yes, First Aid Services will be available throughout the entire event.

## Q. Are pets permitted?

Service animals will be permitted on site, but the event is not open to pets and will not be permitted at the event.

# Q. Will all areas of Paradise Park, including the splashpad, playground, beach volleyball courts, or dog parks be open?

As all guests will be required to stay within their bubble areas, no other areas of Paradise Park will be open on Saturday, July 17.
