Council agrees to provide its share of the project costs of \$5,000,287 and authorizes the Mayor and the Town Clerk to enter into an agreement with the Department of Transportation and Infrastructure on behalf of the Town of Paradise.

11. New/Unfinished Business

a. Department of Corporate Services

Deputy Mayor Laurie brought forward an update from the Corporate Services Department.

 Nominations for the 2021 Municipal General election closed on August 31, 2021. The complete list of Candidates running can be found on the Town's website. Mayor Bobbett was the only candidate nominated for the position of Mayor and therefore was declared acclaimed at the close of nominations.

Residents are reminded that the Town will be holding a hybrid election this year with the option to vote by mail or in person.

For residents wishing to vote by mail, please visit the Town's website at www.paradise.ca/mailinvoting to request a voting kit. All requests require a photo ID showing the voter's current address to be approved. If you are not on the voters list or have moved within paradise since the last election, you will be required to request to be added to the voters list or to update your information, this can also be done through the Town's website. The deadline to request a mail in kit is September 15 at 4:00 p.m.

For those voters planning to vote in person, there are 3 options available:

- Advance Poll Saturday, September 18, 8:00 a.m. to 8:00 p.m. at the Paradise Double Ice Complex.
- Advance Poll Saturday, September25, 8:00 a.m. to 8:00 p.m. at the Paradise Double Ice Complex.
- Election Day Tuesday, September 28, 8:00 a.m. to 8:00 p.m. Polling stations will be held at both the Paradise

Double Ice Complex and St. Thomas Community Center. Leading up to election day voters will be able to check the website to find out where to vote. The street listing will also be posted in the Shoreline.

b. <u>Department of Infrastructure and Engineering</u>

Councillor Quilty brought forward an update from the Infrastructure and Engineering Department.

 This year's construction projects that have been active in the spring and summer are now cluing up while a few fall projects are about to begin.

Paradise Road, phase 4, is nearly complete, but will continue with very little activity while the Town waits for a pole to be relocated by NL Power. Once the pole is relocated, all activity should quickly come to an end.

The last of this year's road rehabilitation and patching work is also finishing up. A large patch on Camrose Drive and one on Topsail Road by the Fire Station are the last areas planned for this this project. Both are expected to be complete by the end of this week. A few more areas may be added before the end of the contract to maximize use of the budget.

The Artificial Turf and Woodstock Gardens Park projects are about to start. The Topsail Road roundabout center feature installation is another fall project that will be underway before the end of the year.

c. <u>Department of Planning and Protective Services</u>

Councillor Willis brought forward an update from the Planning and Protective Services Department.

 The Town of Paradise Municipal Enforcement Division, along with the Royal Newfoundland Constabulary, issued several tickets during the August 28-29 weekend to ATV and dirt bike users for driving without a license plate, operating without insurance, and operating on a highway. These tickets were issued as part of ongoing patrols to address the illegal use of ATV's in the Town of Paradise. d. Department of Public Works

Councillor English brought forward an update from the Public Works Department.

Its back-to-school time!

Over the past week, our Public Works team have been busy installing traffic calming devices, scheduling for on site flag persons during the morning and evening dismissal for each school as well as ensuring all school zones are free of any obstacles.

We all know that when the school doors open, traffic gets heavier on our streets. People are back from holidays, school buses and public transit are on regular routes, and more people are walking, cycling, or driving to school. With the congestion on school days, it's never more important for drivers to slow down and pay attention than when kids are present – especially before and after school.

Schools often have very specific drop-off procedures for the school year. Make sure you know them for the safety of all kids.

To help with the transition, its important we all share the roads safely.

e. <u>Department of Recreation and Community Services</u>

Councillor Martin brought forward an update from the Recreation and Community Services Department.

• The Town of Paradise wants to hear from residents about amenities for the newest trail, Adams Pond. Since being completed in 2020, the Adams Pond Trail has become well-used by residents. The Town has retained Mills and Wright Landscape Architecture to engage residents to get input on the types of amenities needed for the Trail. The input gathered from the public engagement will help guide the development of an amenity concept plan for Adams Pond Trail.

The first phase of the public engagement involved a Trailside Popup today. Consultants from Mills and Wright will be on the Adams Pond Trail, Wednesday, September 8, between 9-11 am and Thursday, September 9 between 6-8 pm, seeking input directly from users. The consultants will also be in the lobby of the Paradise Double Ice Complex on September 8 and 15th from 6-8pm. Residents can also send in feedback by visiting: www.millsandwright.ca/adamspond. Share your input and help us plan for the Adams Pond Trail amenities.

f. Other

- Deputy Mayor Laurie congratulated Mayor Bobbett on his acclamation for Mayor. Mayor Bobbett responded that he is honored.
- Deputy Mayor Laurie wished good luck to the nine (9) candidates that are running for Council. She stated that it is great to see so many people come forward. Deputy Mayor Laurie also congratulated Councillor English and Councillor Willis on their retirement.
- Councillor English asked for an update about the financial information that he requested at the last meeting regarding outstanding accounts. CAO Niblock requested that Councillor English send her an email that outlines the requested information as she was not at the last meeting.
- Councillor English asked if there was an update from an email that he sent August 23 regarding an issue on the property at 83 Elizabeth Drive. He wanted to ensure that the resident had been contacted.
- Councillor Street has received several calls from residents inquiring about the completion of the roundabout on McNamara Drive. CAO Niblock responded that the project is being completed by the Department of Transportation and Works and the Town was told that it would be ready for when the new school opened. CAO Niblock also noted that there is going to be marked vehicles with flashing lights at each school and there will be flags persons directly traffic for the first few days. Also, all four (4) of the elementary schools will have crossing guards. There was also additional traffic calming measures installed by Octagon Pond Elementary last week.

- Councillor Quilty congratulated Mayor Bobbett and wished good luck to those campaigning. She also wished a happy retirement to Councillor Willis and Councillor English.
- Councillor Willis congratulated Mayor Bobbett and said that is was good to see him back in the chair. He also thanked the residents of Paradise for their outstanding support and friendships throughout the last 30 plus years. Serving on Council has been a very rewarding experience. There have been many achievements over the past 30 years and the Town has grown. Councillor Willis also thanked all the staff throughout the years for their dedication to public service. Mayor Bobbett thanked Councillor Willis for his years of service.
