The committee discussed the Karwood Drive & Topsail Road Crosswalk Traffic Calming Engineering Services tender results and recommended Council award the contract to the low bidder.

The committee also discussed the results and recommended the award of the 2023 Line Painting Program contract.

Staff were asked to provide the status of the controller for the Topsail Road crosswalk at Marie's Mini Mart.

Staff were also notified of a resident concern with the light sequencing at Carlisle Drive and Topsail Road.

The committee reviewed a letter from the province regarding the deadline to close out the Paradise Road Phase 4 construction project.

Staff informed the committee that the delegation by Mr. Brown at the November 22, 2022 committee meeting about the original plan for Lift Station #10 was overlooked in the December 6, 2022 committee report.

upgrades to the current lift station that will allow for future flows in the Town. He believes that there is still a viable option.

- Councillor Laurie attended the Regional Economic Development Presentation last Wednesday at the City of St. John's with CAO Niblock. It was very informative and additional information on this initiative will be available in the new year.
