Deputy Mayor Street thanked the members of the Paradise Needs a High School Group for attending a recent session of the House of Assembly Question Period.

Councillor Laurie informed Council and residents that she attended Hauntober Event with the Mayor on October 14. She thanked staff for organizing a great event, and although the weather prevented the hayrides from going ahead, residents enjoyed the other activities. As part of the event, staff had a Fall Photo Area in the lobby of the Paradise Double Ice Complex, and residents are advised it will be available until the end of October.

Councillor Laurie informed Council and residents that her and Mayor Bobbett attended the Polka Dot Trot fundraiser for the H. Bliss Murphy Cancer Care Centre. The event was held in Paradise Park and she received great feedback from the organizers about the location and support from Town staff.
