The Infrastructure & Engineering Committee met on August 13, 2024.

The committee requested and received updates on the status of a sight line investigation on St. Thomas Line and on the planning progress for completion of the Stephanie Drive trail.

Four contemplated change notices were reviewed and recommended for acceptance. The change notices included changes to add a 3-way switch to Lift Station #10, to add the installation of air release valves to the force

main on St. Thomas Line, to add adjustable manholes to the Topsail Road maintenance project, and to implement a revised design for the Glendarek Drive upgrade. The last three contemplated changes were also recommended to proceed via email poll of council to expedite decisions.

Contracting contract administration and site inspection responsibilities for the Glendarek Drive project to Irvine Engineering as a change order to their current contract was discussed and the recommendation was to proceed with an email poll of Council for this item. The remaining 2024 Street Capital Budget and the current demands were reviewed by committee.

The Capital Projects Status and Pond Level Reports were presented for information.

 high-level concerns facing our Town.
- Deputy Mayor Street participated in Paddle in Paradise Dragon Boat Races last Saturday with other members of Council, Town Staff and friends and family. It was a wonderful event with 12 teams participating and thanks to all the volunteers, sponsors and Town Staff. Deputy Mayor Street congratulated the first place team "Come From Away" from

Waterloo, the second place team "Friends and Family Mad Hatters and the third place team the Mighty Municipal Dragons. A special thank you to the Avalon Dragons for all they do in supporting breast cancer survivors.

- Deputy Mayor Street thanked the Paradise Kin Club and Lions Club for the food drive that took place over the weekend during the Sunsplash Events. The groups worked together and collected a significant amount of food for the CBS Paradise Food Bank and over \$750 in cash donations.
- Mayor Bobbett noted that he attended some of the great Sunsplash events over the weekend. He informed Council that the Avalon Dragons made in excess of \$24,000 for a fantastic cause.
- Councillor Martin noted that it was a great event on Saturday and a
 wonderful fundraiser for the Avalon Dragons raising over \$24,000. Paddle
 in Paradise had a smaller attendance this year, but it was fun and a great
 competition. Mayor Bobbett noted that he put out the challenge to
 neighbouring Municipalities and that it was great to have Minister Hutton
 was in our boat.
- Councillor Martin informed Council and residents that the last Summer Jam Concert is taking place on Saturday, August 24 at Peter Barry Duff Beach at 6:30 pm. The performers are Mike Mahoney and Melody Rodgers.
- Councillor Martin noted that there is a Youth Outdoor Ball Hockey event at Peter Barry Duff Memorial Park on August 25 from 1:00 pm-2:30 pm for youth ages 10-14 years of age.
- Councillor Carew attended some of the Sunsplash Events over the weekend and brought greetings at the Family Event on Sunday. He noted what a great facility Paradise Park would be for some larger concerts. It was great to see the donations coming in for the Food Bank.
- Councillor Carew discussed the illegal use of dirt bikes and ATV's in the Town and reminded residents that the Town does have a motorized trail that can be used. He noted that continued partnership with the RNC is important to put additional safety measures in place.
- Councillor Maher asked when the work on Topsail Road will be completed? Deputy Mayor Street responded that the work is anticipated to be completed by August 29.

- Councillor Maher asked when the sidewalks around Holy Family School
 will be cleaned up? Deputy Mayor Street responded that there is a portion
 of sidewalk on St. Thomas Line by Lanark Drive will not be reinstalled until
 the air release valves that were awarded today get installed, the gravel on
 the sidewalk is with Public Works for clean up and the sidewalk that was
 cracked and raised is marked out for replacement. This will be brought to
 the Infrastructure and Engineering committee next week for further
 discussion.
- Councillor Maher attended some of the Sunsplash Events on the weekend and thanked staff and volunteers for all their efforts to make the events a success. Councillor Maher noted that he was honored to be in the boat on Saturday with the Mighty Municipal Dragons. It is a cause near to his heart as his wife is a breast cancer survivor.
