### 12. New/Unfinished Business

- Deputy Mayor Street attended the Pink Tie Gala on November 23. This
  event was a celebration of the 100<sup>th</sup> anniversary of women gaining the
  right to vote in Newfoundland.
- Deputy Mayor Street attended the tree lighting on Friday Night, brunch with Santa on Saturday and the parade on Sunday. It was great to see all events well attended. Deputy Mayor Street thanked all the performers, the Kin Club, the cadets, all the volunteers, Kings Photography, all those who had floats in the parade and Town Staff and Santa for making all these events a success.
- Deputy Mayor Street reminded residents to visit the magical lights at Peter Barry Duff Park. The park will be lit up until January 6.
- Councillor Quilty couldn't attend the festivities this weekend due to sickness but thanked staff for all their hard work.
- Councillor Carew provided an update on Lift Station 10 repairs. The
  source of the recent failure has not been identified as the flows have been
  too high to complete an inspection and there is still a lot of water on the
  ground due to the rainfall. Once the issue is identified the intent is to
  complete repairs, but the by-pass will remain in operation until the new lift
  station is completed. Progress is ongoing on the new lift station and the
  intent is for it to be operational by the end of January, early February.
- Councillor Carew sent support on behalf of Council to the City of Mount
  Pearl on their recent acts of violence in the community. He noted that we
  all have a part to play in reporting all criminal activity to the RNC and he
  hopes for speedy justice on these issues.

- Councillor Carew congratulated Liam Hickey and Gavin Baggs on being named to Canada's National Senior Para Hockey Team for the 2024 Para Cup which is taking place in PEI from December 8-14, 2024. He wished them good luck as they represent Newfoundland and Labrador.
- Councillor Maher asked if there was any new information on the high school that can be made public? Councillor Quilty responded that there is no new information to bring forward but as soon as there is an update it will be brought forward.
- Councillor Maher asked about recruitment in the Public Works department for snow clearing this Winter and what caused the delay of crews getting out on the roads in the recent ice storm. Councillor Carew noted that there is considerable success with recruitment for staff for snow clearing season and there are only 2 vacant positions that should be filled by the end of this week. Councillor Carew also noted that all Council received numerous concerns on the condition of the roads on Monday, after consulting with staff the problem was identified, and changes have been made to ensure consistency going forward.
