# 13. Community Highlights

- Deputy Mayor Street recognized 2 Paradise youth in the sport of Taekwondo. Last week Blake Brennan and Kaiden Crocker attended the Canada Taekwondo Nationals and the Canada Taekwondo Open in Montreal. Blake ranked 4th in his division and Kaiden won the gold medal in his division. Kaiden won gold at the Canada Open and has earned a place on Team Canada and will represent our country at the Pan Am games in Mexico this April.
- Deputy Mayor Street stated that her thoughts are with staff as they navigate through the changes since the fire at the Depot on February 9. This fire has displaced all staff that work at the Town Hall and Depot Building.

- Deputy Mayor Street noted that she brought greetings at the Snow and Ice Seniors Social last Friday. She also noted that she attended the Spirit of Newfoundland Dinner and Show with all Council on Saturday evening, and it was a great evening. Deputy Mayor Street also brought greetings at the Family Good Bingo on Sunday evening. She thanked the Kin Club for hosting the event and congratulated Gerald Healey for receiving the 75th Confederation Medal for forty (40) years of volunteering with the Kin Club.
- Councillor Vaters echoed Deputy Mayor's comments on the Snow and Ice events this past weekend and the resiliency demonstrated by staff during the ongoing issue that we face from the fire and the impacts. He noted that he really appreciates all the efforts being made by staff.
- Councillor Vaters discussed the Yellowwood Drive to Devaughn Street connection and traffic calming measures. He noted that in recent months, Council have received a number of emails from residents on both of these streets expressing some concerns about the connection and what it will mean for traffic flow and speeds in the area. Councillor Vaters stated that there are a lot of children in these subdivisions that ride their bikes and play and visit their friends without any major concerns and noted that he feels the Town needs to collect information and consider traffic calming measures before the connection is made and add further traffic calming measures if required after the connection is made. He also stated that it would be very beneficial to engage with the residents along the way.
- Councillor Martin echoed Councillor Vaters comments on the Yellowwood Drive and Devaughn Street connection and stated that he has heard a lot of concerns from residents.
- Councillor Martin informed residents that the Paradise Park Master Plan Presentation went well and that the plan will be added to the website for any residents that would like to review it and provide feedback until early March.
- Councillor Martin attended the Spirit of Newfoundland Dinner and Show and the Family Goods Bingo this weekend.
- Councillor Martin informed residents of the remaining Snow and Ice events taking place this week. This evening is Poker, tomorrow there is Bowling, Trivia at Banished Brewery and Cardio Fitness with Whalen Wellness. On Thursday there's Karaoke at Banished Brewery, Friday there is a Shinny Hockey Demonstration and a Nerf Battle for ages 7-14.

On Saturday there's a family tot time with Superhero's and Princesses, a Cornhole Tournament and the mini market and on Sunday there's Family Trivia at Banished Brewery and Talent Night. There is something taking place for everyone.

- Councillor Maher noted that there is weather showing in the long-term forecast and he asked residents to be patient with staff as there was snow clearing equipment lost in the fire.
- Councillor Maher encouraged residents to attend the upcoming Snow and Ice events.
- Councillor Quilty acknowledged the great events coming up with Snow and Ice and stated that she enjoyed the dinner and show on Saturday evening.
- Councillor Quilty reminded motorists to be extra careful around the schools.
- Councillor Quilty noted it was a great presentation with Mills and Wright last night on the Paradise Park Master Plan and stated that she is looking forward to moving ahead with the feasibility study for the pool this year.
- Councillor Carew reminded residents that snowmobiles are not to be on the trails or cutting through private property and he noted that the only motorized trail is the T'Railway. Municipal Enforcement are stepping up patrols and the RNC have been notified of the concerns.
- Councillor Carew noted that it is going to be difficult to get appropriate data before the connection between Yellowwood and Devaughn takes place. Councillor Carew voiced concerns about the safety of the children living in this area that have used the road for recreational purposes. This connection will change the dynamics of the neighbourhood dramatically and it is paramount to have traffic calming in place.
