- Councillor Vaters congratulated the Mount Pearl Paradise Open Starlites Synchronized Skating Team for placing first at the 2025 Skate Canada Cup and requested that the team attend an upcoming Council meeting to be acknowledged publicly once the meetings go back in person and it can be accommodated.
- Councillor Martin thanked Mayor Bobbett for his speech at the Mayor's Outlook last week. He noted that it was a great speech and a lovely event to attend with the majority of Council.
- Councillor Martin also congratulated the Mount Pearl Paradise Open Starlites on receiving gold.
- Councillor Quilty passed along congratulations to the Open Starlites for capturing the 2025 Skate Canada Cup Championship.
- Councillor Quilty informed residents that staff issued permits for eleven new residential buildings between January 20 and February 14. These builds add nineteen new housing units to the Town.
